Dear Sir,

- The Board of Directors of the company at its meeting held on Wednesday 24th February, 2016 has appointed me as a Scrutinizer for conducting the postal ballot voting process and E-voting process.
- 2. I submit my report as under:
 - On, 25th February, 2016,the Company had completed the dispatch of Postal Ballot forms along with postage prepaid reply envelope to its Members, whose name(s) appeared on the Register of Members/List of beneficiaries as on 19th February, 2016 and also published Newspaper Advertisement in Free Press Gujarat (English) and Lokmitra (Gujarati) edition dated February 27, 2016 declaring 19th February, 2016 as cutoff date for the purpose of voting rights for postal ballot.
 - 2.2 The e-voting commenced from Friday 26th February 2016, 9:00 a.m. and ended on Saturday 26th March, 2016 upto 5:00 p.m.
 - 2.3 Particulars of all the postal ballot forms received from the Shareholders have been entered in a register separately maintained for the purpose in electronic mode.
 - 2.4 I have downloaded the data of e-voting from the E- Voting website of Central Depository Services (India) Limited (https://www.evotingindia.com/) after the E-voting module was disabled by the Central Depository Services India Limited (CDSL) on 26th March, 2016 at 5.30 P.M
 - 2.5 The Postal Ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
